Project rationale

- Youth-led organisations in the drug policy and harm reduction sector can often suffer from a range of capacity issues. The key issues we had identified were:
- 1. Poor Leadership Transitions
- 2. Poor Institutional Knowledge/Memory
- 3. Lack of Long-Term Strategy.
- There is often a lack of a clear strategy for non youth organisations to meaningfully engage with young people and youth organisations







Project Objectives

Strengthen leadership transitions, institutional memory, and long-term strategies in youth-led drug policy and harm reduction organizations through the development and implementation of a youth-work Sustainability Framework, blending best practices from both the youth-work and drug policy/harm reduction sectors.

Strengthen non-youth organisations capacity and understanding to engage with young people and youth-led organisations.






