DISRUPTING THE RESEARCH ENTERPRISE











Lived(-ing) experience can't be taught

Communities are experts in their own culture and needs; research that lacks context can miss the target.

The research enterprise has a bad history

Tokenization,
exploitation,
stigmatization, and
misrepresentation
has been paired with
inequitable benefit.

The researched can be the researchers

There is a consistent call for PWUD-led research, though the desire for ethical and community-engaged research is not new.

Systemic issues reinforce power differentials

An infrastructure that supports building research capacity, trust, respect, and an organic research priorities is needed.

Research can be a tool for empowerment and change

Research driven by lived(-ing) experience has the potential to produce timely, relevant insight on essential issues.

PEOPLE WITH LIVED(-ING) EXPERIENCE AS RESEARCHERS

Who

The PLER Board includes partners from drug user unions and harm reduction organizations across the United States who are receiving fair compensation for their subject matter expertise to define research priorities, develop a sustainable (and ultimately standalone) infrastructure, and leading research.

What

PLER prioritizes work and partners that meet certain expectations, such as providing opportunities for leadership, authentic engagement throughout, and impact on priority topics.

When

The full board meets monthly to strengthen infrastructure, engage in collaborative decision-making, and support sustainability. Work groups meet ad hoc. Compensation is provided quarterly for invoiced hours.

Where does this live?


American Institutes for Research and the National Harm Reduction Coalition have served in the "backbone" role to provide institutional legitimacy, capacity building resources, and research leadership opportunities. The role of the backbone was designed to evolve over time.

Why is this different?

While the pursuit of empowering research is not new, PLER emphasizes research in which people with living experience are not just participating but they are in the driver's seat.

How is this sustainable?

Funding strategies include grants and fee-for-service agreements through the backbone organizations, with a transition to a solidarity economy.





Measurements for Accountability to All People in Policy Solutions (MAAPPS) recognizes that

- Structural and social conditions facilitate or restrict health
- Intersecting risks amplify the consequences for drug use to create disparities in health outcomes





MAAPPS: Three Phases



PHASE I: Recognize

Engage in a meaning-making process to co-interpret the findings of an **environmental scan** of relevant outcomes and implementation contexts



PHASE II: Connect/Rebuild

Identify shared value space and develop holistic measures of success at a multisectoral convening




PHASE III: Transform

Apply the measures of success to help state align spending to promote restorative justice







- 1. How can different research systems and **funding systems** most efficiently work together?


